**LOCAL UNION PLAN SUMMARY
 FOR ELECTION OF DELEGATES AND ALTERNATE DELEGATES TO THE IBT CONVENTION**

IBT Local Union 25 is entitled to elect 13 delegates and has chosen to elect 3 alternate delegates to the June 2011 IBT International Convention. The expenses of all the delegates and 3 alternate delegates will be paid by the Local Union.

The Election Supervisor has approved the Local Union's plan for conducting nominations and elections. The important details of the plan are summarized below. This summary must remain posted until 30 days after the date of posting of the names of the elected delegates and alternates, whether chosen by white ballot or as a result of a contested election.

NOMINATION	<p>Where: 544 Main Street, Charlestown, MA 02129</p> <p>When: Sunday, February 20, 2011 at 10:00 a.m.</p> <p>Who Can Attend: Any active member may attend any meeting.</p> <p>Who Can Nominate: Members in good standing (full dues paid through January, 2011) may nominate or second the nomination of a candidate or slate of candidates.</p> <p>Who Can Run: A member must be in continuous good standing for a period of twenty-four months prior to the month of February, 2011.</p> <p>Eligibility Deadline: Dues must be paid at the 544 Main Street, Charlestown, MA 02129 before 4:30 p.m. on February 18, 2011.</p> <p>Nominations: Nominations may be made or seconded orally at the nomination meeting or submitted in writing, including the signature and last four digits of the nominator's or seconder's SSN, to the Secretary-Treasurer not later than 5:00 p.m. of the day immediately prior to the meeting.</p> <p>Candidate Acceptance A member may accept nomination in person, or if absent from the meeting, by furnishing a written acceptance, including the signature and last four digits of the candidate's SSN, to the presiding Local Union officer no later than the time the member is nominated.</p> <p>Additional Info: The Local Union will send a Nominations Notice to all members with additional instructions for participating in the nominations process.</p>
ELECTION	<p>Mail Balloting: All members should receive a ballot at their home address before April 1, 2011. Any member not receiving a ballot by that date should request a ballot by calling the local Union.</p> <p>Voting Deadline: VOTED BALLOT MUST BE RETURNED BY MAIL IN TIME FOR RECEIPT NO LATER THAN 9:00 A.M. on April 16, 2011.</p> <p>Eligibility Deadline: Dues must be paid at 544 Main Street, Charlestown, MA 02129 before 4:30 p.m. on April 15, 2011.</p>
